We are pleased to share our 2021 Annual Report and our appreciation to our stakeholders and wider community.

This past year was filled by significant milestones made possible by years of dedicated work. Investments into infrastructure and site readiness. Partnerships to build direct and deep workforce pathways, redevelop downtowns, and to sustain businesses during the COVID pandemic.

Governor Kathy Hochul said it best in helping to kick off Plug Power's \$232 million project at STAMP in October.

"We're ready for the future because of these investments."

That's the spirit behind the GCEDC as we tackle even more activity in 2022.

Plug Power's selection of the STAMP mega site for North America's largest green hydrogen manufacturing project led a wave of activity and interest at Genesee County's shovel-ready sites.

Dozens of businesses have already activated over 75% of the available acreage at GCEDC developed sites in Batavia, Bergen, Le Roy, and Pembroke. More are actively looking to join them, and to employ the talented residents of our county and region.

They are drawn to Genesee County because we are truly open for business. 2021 saw the latest phase of Liberty Pumps' growth in Apple Tree Acres, investments along the Saile Drive corridor with LandPro Equipment and New York Bus Sales, and the launch of projects like Ellicott Station and building improvements through our downtowns.

These projects will have a significant and positive impact in our community well into the future.

We conservatively estimate that the 9 projects advanced through the GCEDC in 2021 have a total economic impact of \$647 million, including investments directly to their facilities and shared infrastructure, 171 new jobs, and significant future property tax base growth.

As we enter 2022, all signs are pointing to more growth in our county and region.

The partnership of our board of directors, professional staff, and leaders like Gov. Hochul, our state and federal legislators – and most importantly, the people of Genesee County – prove that Genesee County is ready for the future!

"This will be the first large-scale green hydrogen network - not only in New York, not only in the U.S., but around the world."

Plug Power CEO Andry Marsh, joined by Gov. Kathy Hochul and leaders from across New York, kicked off the largest business investment in Genesee County history in October – and affirmed the Western New York Science & Technology Advanced Manufacturing Park's role in scaling technological advancements.

Plug Power is now under construction on a \$232 million facility at STAMP, where the manufacturer is build both their operations and an electrical substation with capacities available to serve the entire 1,250-acre mega site.

Plug Power's site location decision is credited to STAMP's unique ability to deliver large-scale, 100% renewable energy at under \$0.04/kwh and the completion of a 1 million gallons per day water supply at STAMP.

New York's proactive investment in infrastructure and the completion of all site-level environmental and pre-project due diligence allowed Plug Power to quickly break ground.

"Let me put an explanation point on that – we're ready for the future because of these investments," Gov. Hochul said at the project's October kickoff.

Plug Power's investment and construction brings new attention to the assets available at STAMP and across the Buffalo-Rochester Tech Corridor. Site selection experts weighed in April during a virtual "State of Site Selection" event.

"The ability to land that community-changing project takes years of due diligence, and the efforts by the leaders just to continue to see it through," said John Longshore, now the Senior Managing Director at Newmark Global Corporate Services. "(Genesee County) has done that very strategically. The strong, focused effort has been very evident."

Longshore, along with Global Location Strategies President Didi Caldwell and Senior Consultant Andrew Ratchford, noted that STAMP's operational competitiveness already outpaced peer sites.

The site selection experts say the announced construction of STAMP's electric substation, and bid-readiness of major water, wastewater and natural gas expansion place our region even higher on the list of ideal locations.

"With these improvements, (STAMP) jumps far and above the rest of its competitors," Ratchford said.

Craft Cannery shows recipe for success

Restaurants, grocery stores, and start-ups looking to market family recipes are all finding their way to Genesee County and the team at Craft Cannery.

A location at Apple Tree Acres enables the nimble contract manufacturing operation to service a variety of sauces, dressings and marinades in pilot programs, small batch, and mid-size production runs.

Supported with a loan approved in October by the Genesee Gateway Local Development Corporation, Craft Cannery more than doubled its production capacity with new filling equipment added at the end of 2021.

With popular products like Guglielmo's Home Grown Marinara Sauce and Coach Tony's Buffalo Wing Sauce, the increased production is another tasty benefit of Genesee County's food and beverage expertise.



The Buffalo-Rochester Tech Corridor's economic recovery from the COVID-19 pandemic progressed from stability to growth in 2021, as projects highlighted by Batavia's Downtown Revitalization Initiative have Main Streets poised for new life.

The Batavia Development Corporation has identified 9 projects projected to accomplish major milestones in 2022, including major brownfield redevelopments, investments in public performance spaces, new apartments overlooking downtown, and the Healthy Living Campus.

The \$51.6 million of milestone projects, and over a dozen projects supported by the Downtown Revitalization Initiative, New York Main Street Program and Building Improvement Fund, are quickly reshaping the look and activity in downtown Batavia.

Demolition began in November at Ellicott Station, a \$22.4 million project at the connection point of the Ellicott Street and the Ellicott Trail. Supported by the GCEDC, BDC, and New York, the critical redevelopment project will add 55 residential units and a brewery-restaurant at a formerly neglected brownfield.

Apple Tree Acres welcomes latest Liberty Pumps expansion

Building on the success created by a strong workforce and forward-looking leadership, businesses in Genesee County's shovel-ready sites continue to expand beyond their initial projects.

Liberty Pumps broke ground in October on the family and employee-owned manufacturer's \$13.5 million Materials Center.

The project is the third major expansion for Liberty Pumps since 2000 at Apple Tree Acres, enabling more space to serve customers worldwide from Bergen, NY with the support of the GCEDC's site development, project incentives, workforce development investments, and Foreign Trade Zone benefits.

"We're excited to begin another project that will benefit our approximately 300 employees, and add to our presence in Genesee County," Charlie Cook, CEO & Chairman of

Liberty Pumps said at the groundbreaking.
